The following is the local educational agency’s (LEA’s) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Through various community engagement opportunities during the 2020-2021 school year, CUSD gathered and streamlined feedback to inform the develop of the CUSD Expanded Learning Opportunities Plan. All feedback was incorporated into the development of the specific strategies for providing supplemental instruction and support to identified students.

CUSD facilitated parent and staff surveys throughout the 2020-2021 school year via ThoughtExchange software. Results from these parent surveys provided CUSD with direction related to what supports and structures are needed relative to providing academic interventions, extended school year opportunities, increased opportunities for in-person learning and considerations for the 2021-2022 school year. Below is a summary of the ThoughtExchange questions and participation rates:

1. Parent & Staff - 10/8/2020: What are the most important steps CUSD can take to ensure Every Child, Every Day feels safe, valued, and respected while in our care?

252 Participants, 180 Thoughts, 3,832 Ratings

2. Parent & Staff - 1/28/2021: For summer 2021 offerings, what do you consider are essential activities, topics, and courses we should offer to support our students?

75 Participants, 81 Thoughts, 907 Ratings

3. Parent & Staff - 3/17/2021: What programs or services would you like to see continued or improved in order to advance student and staff learning and wellness for the 2021-22 school year?

152 Participants, 156 Thoughts, 4,361 Ratings

Additionally, administrators worked with teachers and/or counselors at each school site to gather student achievement data from the 2020-2021 school year. Administrators used this data (benchmark assessments, course grades, teacher feedback, etc.) to create a list of students in need of academic or social-emotional supports. The identified needs from these student lists have informed and prioritized actions and targeted supports within this plan.

Furthermore, this plan was presented to the Association of Coronado Teachers (ACT) and CUSD California School Employee Association (CSEA) to review and provide input prior to the May 20, 2021 Governing Board meeting where this plan will be reviewed in a public meeting as an action item for approval. This plan was also posted on the CUSD website for parents and staff to provide input using a Google form prior to the May 20, 2021 Governing Board meeting. This plan was Board approved on May 20, 2021.

School site administrators worked with teachers and/or counselors at each school site to gather student achievement data from the 2020-2021 school year. Administrators used this data (benchmark assessments, course grades, teacher feedback, etc.) to create a list of students in need of academic or social-emotional supports. The identified needs from these student lists have informed and prioritized actions and targeted supports for remediation in reading, math and credit recovery opportunities.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Parents/guardians of students who have been identified as needing additional academic or social-emotional supports have been contacted and provided a Google form to make a commitment to participate in the CUSD summer school program.

A description of the LEA's plan to provide supplemental instruction and support.

The learning recovery program that CUSD has designed is focused on providing supplemental instruction and supporting social and emotional well-being. CUSD is participating in the Seamless Summer Meals program and will also continue to provide bulk meal distribution for as long as waivers allows for. Beyond that, CUSD is committed to continuing to provide meals for all students in need, especially students from low-income families, English learners, foster or homeless youth, students with disabilities, students at risk of abuse, neglect, or exploitation, disengage students and students who are performing below grade level. The CUSD Expanded Learning Opportunities Plan was developed to provide tiered supports to identified students, adhering to the Multi-Tiered Systems of Support (MTSS) framework and in coordination with the foundational training CUSD has already provided related to Positive Behavioral Interventions and Supports (PBIS), Responses to Interventions (RTI) and MTSS. Through the MTSS lens, CUSD will be able to create an individualized accelerated learning path for identified students, beginning with universal supports and incorporating targeted and intensive supports where appropriate. The CUSD Expanded Learning Opportunities Plan will include the following supplemental instruction and support strategies in accordance with the MTSS framework:

1. Extending Instructional Learning Time: CUSD will provide identified students the opportunity to participate in a summer school program during summer 2021 and summer 2022. The summer sessions will be focused on increasing instructional time through providing remediation for students in grades TK-12 in the areas of reading, ELA, mathematics, and credit recovery (high school level). Priority will be given to students who are below grade level, and credit deficient (high school level).

2. Accelerating Progress to Close Learning Gaps Through the Implementation, Expansion, or Enhancement of Learning Supports: CUSD will provide educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps. Targeted training related to current CUSD adopted academic intervention materials and programs (College Preparatory Mathematics, Benchmark Advance, Bridges in Mathematics, and Read 180) will serve as the foundation curricula for these trainings. Additionally, during the 2021-2022 school year, CUSD will provide extended learning opportunities to students in middle and high school to receive supplementary instruction through tutorials before and after school in core subject areas.

3. Integrated Student Supports to Address Other Barriers to Learning: CUSD will provide targeted supports to address barriers to learning for students experiencing social-emotional or mental/physical challenges. CUSD will hire the following positions to mitigate barriers to learning and support student mental/emotional/physical health:

* Elementary MTSS/Equity Clinical Counselor: a split 1.0 FTE for Silver Strand and Village Elementary Schools

- * Middle/High School MTSS/Equity Clinical Counselor: a split 1.0 FTE for Coronado Middle and Coronado High Schools
- * Instructional Coach for MTSS/Equity: 1.0 FTE for Coronado High School
- * Coordinator of Special Education: 1.0 FTE reporting to the Department of Student Services

4. Community Learning Hubs that Provide Students with Access to Technology, High-Speed Internet, and Other Academic Supports: CUSD will continue to secure additional instructional technology to support students and staff. Additional devices and carts will be purchased to support student learning. Software licenses will be renewed and newly purchased to provide supplemental academic supports. CUSD will also ensure that personnel are available to provide instructional technology supports.

5. Supports for Credit Deficient Students to Complete Graduation or Grade Promotion Requirements and to Increase or Improve Students' College Eligibility: CUSD will be adopting a new bell schedule structure at Coronado High School during the 2021-2022 school year. This structure will provide expanded learning opportunities during the school day for students to remediate grades in order to get back on track with graduation and A-G eligibility requirements. Support classes will also be incorporated into the new bell schedule structure, based on student data and need. Additionally, CUSD will partner with an instructional coach or consultant to offer targeted supports for teachers in the areas of instructional pedagogy focused on ensuring that all students are able to engage and access the curriculum.

6. Additional Academic Services for Students: CUSD will provide additional diagnostic, progress monitoring, and benchmark assessments of student learning. Analysis of these academic measures will enable CUSD staff to provide targeted supports for struggling learners. A preliminary analysis of 2020-2021 achievement data shows that students with disabilities have fallen further behind due to the effects of the COVID-19 pandemic. As such, CUSD will provide additional resources to support special education teachers and students. Additional hours for paraprofessionals will also be provided as needed for individual or small group supports.

7. Training for School Staff on Strategies to Engage Students and Families in Addressing Students' Social-Emotional Health and Academic Needs: CUSD will continue to build upon the foundational training that has already been provided with our CUSD MTSS initiative and provide additional professional learning for certificated and classified staff in the areas of PBIS, restorative practices, integrated SEL strategies, building learning communities after a pandemic, Thrively and Sanford Harmony.

CUSD intends to coordinate its ELO Grant funds with funds received from the federal Elementary and Secondary School Emergency Relief (ESSER) Fund provided through the federal Coronavirus Response and Relief Supplemental Appropriations Act of 2021, also known as ESSER II, to maximize support for students and staff. Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
