



## KINDERGARTEN/TRANSITIONAL KINDERGARTEN For School Year 2021-2022

Dear Parent or Guardian,

We are looking forward to welcoming your child into Kindergarten or Transitional Kindergarten in Coronado Unified School District for the upcoming 2021-2022 school year. As your student begins in our District, it is important to share information regarding Coronado's Kindergarten/Transitional Kindergarten programs.

According to California Education Code 48000, if your child has his or her fifth birthday on or before September 1, 2021, he/she may enroll in Kindergarten. If your child has his/her fifth birthday between September 2, 2021 and December 2, 2021, he/she will be enrolled in Transitional Kindergarten. CUSD enrolls only students who meet the cutoff dates and does not enroll children who turn 5 after December 2 into Transitional Kindergarten. Transitional Kindergarten is the first of a two-year kindergarten program that uses modified kindergarten curriculum that is age and developmentally appropriate.

The following chart is helpful to determine enrollment in Kindergarten or Transitional Kindergarten.

Kindergarten	5 <sup>th</sup> birthday falls between September 2, 2020 to September 1, 2021
Transitional Kindergarten	5 <sup>th</sup> birthday falls between September 2, 2021 to December 2, 2021

Kindergarten and Transitional Kindergarten online registration for Coronado Unified School District's 2021-2022 school year began on May 10, 2021. Detailed information about the registration process for kindergarten can be found on the attached form.

## Kindergarten Registration for 2021-2022

Kindergarten online registration for Coronado Unified School District's 2021-2022 school year began on May 10, 2021. Parents must complete the online registration process. A link to register will be available on CUSD's website, at [coronadousd.net](http://coronadousd.net) under the "Parents & Students" tab. In addition to registering online, parents are required to attend in-person registration by appointment only.

### **Admission to Traditional Kindergarten:**

A child shall be admitted to traditional kindergarten if the child will have his or her 5th birthday on or before September 1, 2021.

### **Admission to Transitional Kindergarten (TK):**

All children who will have their 5th birthday between September 2—December 2, 2021, must be admitted to Transitional Kindergarten, a two-year kindergarten program. CUSD offers TK at both Silver Strand and Village Elementary School.

### **Required for Registration:**

Parents must provide the following to complete the registration process:

- Certified copy of birth certificate, passport, baptismal certificate, or other affidavit (see Ed Code 48002)
- Original immunization record
- School Entry Health Exam (Kindergarten only) [\*form attached\*](#)
- Oral Health Assessment (TK & Kindergarten) [\*form attached\*](#)
- Any two of the following documents (stating your name and current address) as proof of residency:
  - Property tax payment receipt
  - Rental property contract, lease, or payment receipt
  - Utility bill (current)
  - Payroll Stub (current)
  - Voter Registration
  - Auto Registration
  - Correspondence from a government agency (current)

Individuals who request Joint Residency and/or Caregiver approval to enroll students into schools in the Coronado Unified School District must follow procedures to document proof of residency. All forms must be completed, and documentation provided before students may register.
