Dear Coronado Unified School District Families:


Members of the Board of Education have authorized limited home-to-school transportation for the 2020 – 2021 school year for Coronado Middle School and Silver Strand Elementary School students living in the Strand Housing and the Cays; and for Coronado Middle School and Village Elementary School students living on the Naval Amphibious Base. No transportation will be provided for Coronado High School students.

If you need bus service for your middle or elementary school student, please complete the attached Transportation Request form, sign the Rules of Conduct form, and return both to your student's school during the school's assigned registration period in August. Those requesting transportation will be placed on an official list – space is limited. Bus passes and bus routes will be provided by the schools' office.

Because the transportation coordination with the South Bay Union School District changes annually and must be thoroughly reviewed, the 2021-22 and future years could offer different arrangements.

### **RULES OF CONDUCT**

Students transported in a school bus shall be under the authority of, and responsible directly to, the driver of the bus. Each student who rides the school bus will comply with the directives from the bus driver, treat other students and the bus driver in a cooperative and respectful manner and observe the following rules:

- Students are to be at the bus stop when the bus arrives.
- Students shall pass in front of the bus when it is necessary to cross the roadway.
- Students must wait for the bus to stop completely before boarding.
- Students are to go to their seats promptly after boarding. Seats may be assigned by the bus driver.
- Students are to sit in their seats, facing forward.
- Students are to promptly fasten any passenger restraint system and remain seated while the bus is in motion.
- Students shall remain seated until the bus comes to a complete stop and upon the signal from the driver, unfasten and restraint system, enter the aisle, and go directly to the exit.
- Students should be alert for traffic when leaving the bus and shall safely exit the bus and cross the street.
- Students will close bus windows when so directed by the bus driver.
- The aisles and emergency exits are to be kept clear of all hands, feet, books, backpacks, etc.
- Students are not to speak to the driver while the bus is in motion unless granted permission by the driver or in case of an emergency.
- Behavior deemed inappropriate by the bus driver will not be tolerated.
- Each student who rides the school bus will refrain from any behavior that may adversely impact the safety, health, or well-being of others on the bus and/or damage school district property.
- Students are to report promptly to the bus driver any damage on seats or any other parts of the bus.
- Damage to the bus occurring as a result of carelessness, willful misconduct, negligence, malicious destruction, etc., shall be the financial responsibility of the parent/guardian of the student causing the damage.
- Students may not bring glass containers of any kind on the school bus.
- Students shall not bring animals, reptiles, birds or insects on the bus. Only service animals are permitted.
- Students may bring electronic devices onto the bus only if such devices are permitted at school. If the use of cellular telephones or similar devices disrupts the safe operation of the school bus, the bus driver may direct the student to no longer use the device on the bus.

**The student shall not:**

- Talk or laugh in an unusually loud voice.
- Crowd or push.
- Use profane language or crude gestures.
- Tease, chastise, annoy, or make fun of others.
- Throw articles inside or out of the bus.
- Put any part of their bodies or any article out of the bus window.
- Stand or change seats while the bus is in motion.
- Chew gum, eat, or drink on the bus.
- Violate the District Disciplinary Action Guide.

### **DISCIPLINARY ACTION**

**FIRST CITATION** -The first citation during the school year will result in a written notice to the parent/guardian of inappropriate behavior and will be documented in the student's school record. The student's transportation privileges will be suspended for a period of one week.

**SECOND CITATION AND FINAL ACTION** - Student will be excluded from transportation services for the remainder of the school year. Parents will receive written notification.
